Disposal pricing shall be inclusive of all insurance, labor, tools, equipment, mobilization, demobilization and other expenses necessary to provide proper collection, packaging, transport and disposition of the specified materials received in accordance with all Local, State and Federal regulations and with the specifications and terms and conditions of this bid document and your proposal.

The net weight of each waste category shall be determined by weighing each packed container which includes the container weight and then subtracting the container weight. Each container shall only contain one waste category.
